

## **198 Verges**

The Town Council resolved to add these areas to the contract with Allgardens at the contract Rate per Square Metre of 2p plus VAT for 12 cuts per annum, total bill £141.60pa plus VAT. Total area 590metres<sup>2</sup> = £11.80per cut, x12 pa = £141.60

1. Corner of entrance to Kirby Mills off the A170 - 150m<sup>2</sup>
2. End of Ash Grove between numbers 5 and 10 (off West Pasture) - 120m<sup>2</sup>
3. At the end of town on Gillamoor Rd - 320m<sup>2</sup>. Western side of Gillamoor Road, north of Taymer Lodge.

## **199 A170 Roundabout<sup>4</sup>**

- i) The Town Council noted that any overspend will have to come from the Contingency Fund.
- ii) The Town Council resolved to add the Additional Annual Work of 6 hrs – 2x pruning and removal of debris at the cost of £108pa plus VAT to the contract with Allgardens.
- iii) The Town Council delegated the decision the amount of Start-up work required to the Town Clerk. She will consult with Councillor De Barr and Mrs R Gibson before instructing Allgardens, at a rate of £18 per hour.
