To consider renewing the current lease agreement of the 424HS Green Machine pavement sweeper with Ryedale District Council

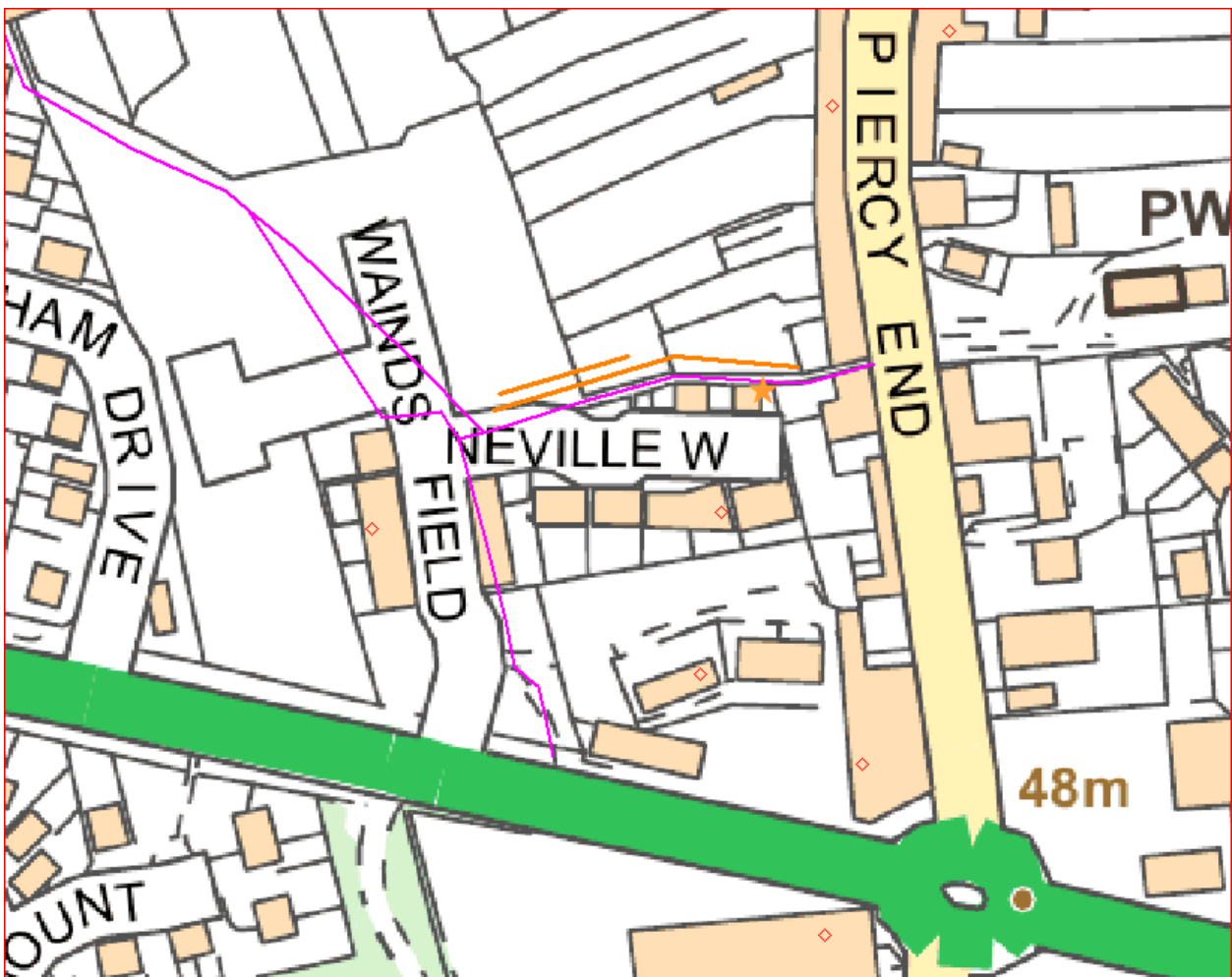

Details of the proposed sign have been on public display on the town blog and on the History Group notice board at the library since 2012.

PUBLIC FOOTPATH FROM PIERCY END, ACROSS NEVILLE WALK AROUND WAINDS FIELD

Works took place on 7th July by Community Payback with provision of materials by NYCC in accordance with the following specifications:



Footpath is a narrowish path that runs mainly between hedges.

Pink lines = public footpaths.

Longer orange line = approx. Distance where new chippings require laying . Nycc will provide 1, maybe 2 x 1 tonne bags of chippings, to be delivered to site (Wains Field / Neville Walk end of path.)

The 1st section of path from Piercy End (between buildings) is existing tarmac surface and does not require any work. Shorter orange line, this is a shallow ditch which has naturally “filled in” and requires digging out again, to a depth of a few inches, so that water can run into a drain at the western end it. The drain looks like just a few stones in the grass.

The orange star on the map is where there is a hawthorn bush beside the path. The bush needs cutting back so that pedestrians aren’t inconvenienced when passing. The branches that are cut off must be removed from site, therefore if the youth justice team cannot do this, then please leave it, and i will do it at some point.

PUBLIC FOOTPATH FROM SHAW DRIVE TO RYEDALE CRESCENT

04.07.13 Upon inspection the public footpath had been cleared of all obstructing vegetation.

COBBLED AREAS

04.07.13 The recent decorating to 6 High Market Place has included parallel white lines being painted on the Cobbled area outside the Wood Carvers Workshop. Of course the pavement is not lowered at this point therefore rendering it inaccessible by vehicle and subsequently these markings are illegal. Melanie Farnham, NYCC Highways, has been informed and will liaise with Graham Ward to resolve the situation. I have been assured that this will not delay the parking trial.

PLAY AREAS

03 & 04.07.13 The gates at Old Road play area have been installed.

04.07.13 The vandals have now targeted one of the benches at Old Road play area, to the left as you enter from Howe End and ripped of one of the seating panels

The ‘DIAL 101 TO REPORT ANTI-SOCIAL & CRIMINAL BEHAVIOUR’ signs have been installed at the play areas together with additional ‘Take the Lead’ dog-fouling notices.

STREET SIGNS

The Main KIRBYMOORSIDE signs have been reported to Highways for refurbishment as they are very grubby.

Several street signs have been reported to RDC for refurbishment as they are illegible as follows:

- i) Market Place - at the junction of Piercy End, Market Place and Howe End
- ii) Piercy End - at the junction of Piercy End, Market Place and Howe End
- iii) High Market Place - at the junction with Tinley Garth, opposite Memorial Hall
- iv) Swineherd Lane - at junction of Swineherd Lane and Old Road.
- v) West End - at junction of West End and Market Place

RAILINGS

04.07.13 Spoke to Richard Milestone and the foundry have made an additional casting frame so the railings are progressing.

NOTICE BOARD
