

#### **COST SHARING AGREEMENT**

## 1 Definitions

'The Five Town Councils' means Helmsley Town Council, Kirkbymoorside Town Council, Malton Town Council, Norton Town Council and Pickering Town Council.

- 1 The District Council is a Principal Litter Authority for the purposes of the Environmental Protection Act 1990 and in discharging this function provides street cleansing services within the area of The Town Council.
- 2 The Five Town Councils have collectively requested that the District Council purchase an additional Pavement Sweeping Vehicle
- 3 The District Council has agreed to purchase a Pavement Sweeping Vehicle for primary use within the Five Town Council's areas.
- 4 The Five Town Council's have collectively agreed to reimburse the District Council for the annual lease and running costs of a Pavement Sweeping Vehicle for a 3 year period in the proportions set out in Part 1 of the Schedule to this Agreement
- 5 The Town Council wishes to put in place additional street cleansing measures in certain areas within its administrative boundary.
- The Five Town Council's also agreed that the Pavement Sweeping Vehicle could be hired out to third parties at an appropriate rate at the discretion of the District Council
- 7 The Town Council at a meeting on......made a commitment to repay the District Council the sum of £...... Being the Town Council's contribution for the costs of the Pavement Sweeping Vehicle minute number ......refers.

# 2 The Agreement

- 1 This Agreement will continue for a period of three years from the date of the lease drawdown
- 2 Obligations of the District Council

The District Council agrees to



- 2.1 Purchase a 424HS Green Machine Pavement Sweeper Vehicle (the Vehicle) to be then financed through an operating lease agreement for a period of three years
- 2.2 Keep and maintain the vehicle in accordance with the manufacturers guidelines and standard industry practice.
- 2.3 Maintain appropriate insurance for the Vehicle.
- 2.4 Provide resources to utilise the Vehicle within the Town Council's area in accordance with the requirements the Town Council as set out in Part 2 of the Schedule to this Agreement
- 2.5 Participate in meetings with the Town Council at least every 3<sup>rd</sup> month to monitor and review the operation of the Vehicle.
- 2.6 Provide a named point of contact for all correspondence relating to this Agreement
- 2.7 Issue invoices to the Town Council on an annual basis in November in the sum of £750 Plus VAT
- 3 Obligations of The Town Council

The Town Council agrees to

- 3.1 Pay to the District Council the sum of £750 per year following receipt of an invoice from the District Council
- 3.2 Provide a named point of contact for all correspondence relating to this Agreement
- 3.3 Participate in meetings with the District Council at least every 3<sup>rd</sup> month to monitor and review the operation of the Vehicle.
- 3.4 Co-operate with the District Council in publicity relating to this agreement.
