CASE STUDY

A Neighbourhood Plan for Otley

Directions Planning Consultancy was originally approached by Otley Town Partnership to provide initial advice in relation to neighbourhood planning and to provide an outline of the process and structures required for preparing a community led plan. The community led plan was initially viewed as an extension to previous strategy documents the Partnership had previously prepared.

Leeds City Council then started consultation on a 'Housing Prospectus' paper which involved responding to a questionnaire and taking part in a series of workshops intended to flush out priorities for housing need and demand across the district.

Directions Planning Consultancy supported Otley Town Partnership through the consultation process, helping to shape the drafting of the response and providing support to the Partnership.

Subsequently, Directions Planning Consultancy made Otley Town Council aware of the Government's Front Runner programme and liaised with Otley Town Council, Otley Town Partnership and Leeds City Council in the drafting of the bid and submission to the Government.

On 1st March 2012, Otley was named as only one of seven parishes in Yorkshire to be awarded Front Runner status.
