Hi,

I want to advise you of a non-competitive Cycle event which will pass through the Parish on the 18th April 2015.

We ran the event in the past 2 years without any issue however we are doing as much work as possible to make people aware of the riders passage for both their and the public safety and to avoid any conflict on the roads.

It's known as a Sportive, riders follow one of 3 routes from Thirsk, it's strictly not a race and no prizes are given.

We do place route signs around the route, these are correx boards with our logos on them which we zip tie to the existing sign posts. These are put up on the day before the event and taken down on the day of the event. We appreciate they are an eyesore so remove them as quickly as possible, usually as soon as the last rider has passed. We make sure the zip tie is removed and not littered.

We anticipate 500 riders in the event, it will start from Thirsk at 08:00. Riders depart in waves of around 100 until 09:00 when the start is closed. There will be a noticeable number of riders in the area all day however once away from the Thirsk start, they are well spread out.

The riders are all briefed about conduct and safety and any issues are addressed with the up most seriousness. We have trained motor cycle marshals out on the course to aid safety, they do not have powers to stop traffic, they can only raise awareness and stop riders.

Could you please pass the notification to the parish so that as many people are aware of our presence as possible, we really want to maintain a good relationship and a safe passage for the riders and residents.

We are a local organisation as are most of the riders. Our participants are mostly families, people new to the sport and lots doing it for a challenge, to get fit or even raise money for charity.
