13. To consider information received from HeartSafe Communities with regards to community defibrillators and agree appropriate action

HeartSafe Communities have been tasked by Yorkshire Ambulance Service with providing defibrillators in 'Red 1 Call' zones of Yorkshire. These are rural areas around our region where it is considered critical that residents have access to a community defibrillator.

Sudden Cardiac Arrest (SCA) is the UKs biggest killer and, approximately 27 of us die in Yorkshire every day. Where early defibrillation is available to a patient, their chance of survival increases from less than 3% to over 80%. The issue with many rural areas is the response time to such an event means effective therapy being delivered by ambulance is unlikely within the critical timeframe.

Working with Yorkshire Ambulance Service we have come up with the most cost effective way to provide these vital pieces of equipment to those that are most vulnerable. This is an unrivalled proposal not available from any other Defibrillator provider.

Last year when the Government provided £1Million through the British Heart Foundation to provide Public Access Defibrillators, it caused a surge of interest from small vulnerable rural communities and worked well to raise awareness of Sudden Cardiac Arrest (SCA) and defibrillation. Unfortunately, that money has all gone now with thousands of unsuccessful applications left still in need of this life saving equipment.

A large portion of those communities still waiting for an AED simply do not have the finance readily available to purchase one immediately. We will provide you with a temporary, reconditioned and re-calibrated device that has a 2 year warranty on it. This means that your community will then have up to 2 years to raise the finance for a brand new device.

This offer is unlike any other available.

- It makes your community Heartsafe straight away
- You get up to 2 years extra heart protection (the time you have the temporary device)
- It gives you time to raise the majority of the funds at a later date
- And the total cost is no more than if you were to purchase 1 outright now.

The costings are worked out as:

- * £700 Initial outlay for temporary device and brand new housing cabinet
- * £995 The cost of purchasing a brand new device when funds are raised, up to 2 years from obtaining temp AED

Total - £1695

Your new AED will come with a warranty of 8 years on it. With this scheme, you get up to 2 years from the temporary device and then another 8 from the new device. So it will be 10 years before you will need to start looking into a new one again.

Incredibly, for every device that is placed through this campaign in Yorkshire, YAS are prepared to hold a training/awareness session locally, with an open invitation to your community. They will look to a community centre/village hall or wherever the device is to be placed to hold the session. This is completely free of charge and is perfect for those who are receiving an AED for the first time.

This offer includes insurance and maintenance at no extra cost.
