

The North York Moors National Park is nationally recognised as a special place. It contains a unique mix of special qualities that make them unique, and something to be protected, celebrated and enjoyed.

It is our duty to make sure that they remain a valuable national asset. We must also recognise that they are somewhere where people live, work and visit, and that we must plan to support these needs.

To this end we have just started work on a new Local Plan for the North York Moors. It will be a development plan, meaning that it will be the main factor in how we decide planning applications for new development in the future. It will also look to identify new locations for housing, employment and open space in the future.

As it will have a big influence over the future of the North York Moors, it needs to be informed by as many views and opinions as possible. We are now asking everyone to let us know their thoughts on what should be in it, and how it should protect and enhance what's special about the North York Moors.

Our 'First Steps' document contains a list of questions which we would value your opinion on. Please do not feel that you have to answer all or only these questions or keep to the structure of the questions – the important thing is that you let us know:

- What do you particularly value about the North York Moors?
- Are there any features or areas that you would like to see altered or improved?
- What approach do you think should be taken to new development in the National Park?
- If you were writing a new Local Plan what do you think are the main issues it needs to address?
