THE ROYAL BRITISH LEGION MEMBERSHIP HANDBOOK PART 3: BRANCHES

3.2.6 BRANCH CEREMONIAL

1.

The Legion is the Nation's custodian of Remembrance, ensuring that people remember those who have given their lives for the freedom we enjoy today. The Poppy has become the symbol of Remembrance worn during the weeks leading to Remembrance Sunday and Armistice Day, though they may be worn all year round if desired.

2.

The national day of Remembrance is the second Sunday in November. **Remembrance Services are the responsibility of the local authorities and branches should always support the Service of Remembrance, taking care to avoid conflict between their own activities and the arrangements for the rest of the community.**

3.

Where there are no local arrangements the branch should approach the church authorities with a request to hold a Service of Remembrance. The form of the service is a matter for the church authorities. Guidance and suggested Orders of Service can be found in the Ceremonial Handbook, which is available digitally through the Area Office.

4.

A wreath may be laid at the local war memorial either in addition to, or instead of, laying a wreath in a church. **The laying of wreaths at war memorials may form part of a short religious service or be a separate Legion - arranged ceremony.** It should follow a simple but dignified procedure appropriate to local circumstances.

5.

The Legion also believes that a Two Minutes Silence should be observed by everyone who is able to do so at 11 am on 11 November. Any special instructions will be issued by Head Office but branches will need to make their own arrangements, in whatever way appears the most suitable, for their members to observe the silence.

6.

Expenses for the organisation of memorial services or parades may NOT be charged against the Poppy Appeal.

7.

The National Festival of Remembrance takes place annually at the Royal Albert Hall (RAH) in London on the Saturday before Remembrance Sunday. There is one presentation in the afternoon and one in the evening. Tickets for the afternoon presentation are sold from the RAH box office and are exclusive to Legion members for a limited period of time. Tickets for the evening presentation are issued exclusively to Legion members and official guests. Details are contained in the Special Circular issued by Head Office annually.

8.

War memorials are the responsibility of the local authorities. Neither the Poppy Appeal nor any other Legion fund may be used in connection with war memorials, unless the memorial is owned by the branch. If action is needed to improve the condition of a local war memorial the local authority should be approached. Local authorities can spend funds to maintain, repair, protect or adapt a memorial to serve as a memorial to subsequent conflicts.

Dear Mr Ashworth

I am writing to let you know that HSBC has announced the planned closure of 62 of its UK branches. As part of this we have taken the difficult decision to close the HSBC branches in Easingwold and Kirkbymoorside, which are located within your area, on Friday 16 June 2017.

The move to close the branches announced today is in response to a significant change in customer behaviour in personal banking. Over the past five years, the number of customers using HSBC branches has fallen by almost 40%. 93% of customers' contact with the bank is now completed via the telephone, internet or smartphone, and 97% of cash withdrawals are made via an ATM.

We have chosen to announce all our remaining planned closures for 2017 in order to be fully transparent to our staff, customers and the communities we serve. The decision to close branches will ensure a more sustainable branch network for the future as we continue to invest in our digital platforms and our people.

We have no intention to close any further branches in 2017 and this marks the end of our branch restructuring programme.

We have informed our colleagues at the branches and, wherever possible, we will work with them to find them alternative opportunities with us. Posters will be displayed in the branches giving details of the closure, and we will be writing to each of our customers of Easingwold and Kirkbymoorside branches on Monday 20 March 2017 providing them with more information about the closure and the alternative banking services available to them.

Following the closure, we will automatically transfer the administration of our customers' accounts to our York, Parliament Street branch. In addition, there are other HSBC branches at Thirsk, Malton and Ripon and all HSBC and first direct personal current account customers can access their bank account at Post Office branches for cash withdrawals, cash deposits, cheque deposits and balance enquiries. We have also reached an agreement with the Post Office to enable business customers with a debit card to pay in and withdraw cash and check their balance, additionally they can deposit cheques using a credit slip and HSBC envelope. The nearest Post Office to Easingwold is located at Market Place, Easingwold, York, North Yorkshire YO61 3AA and

the nearest Post Office to Kirkbymoorside is located at 25 Market Place, Kirkbymoorside, York, North Yorkshire YO62 6AA.

Our main priority is ensuring that we are aware of any difficulties faced by our customers. With this in mind, our branch staff are available to talk through the many alternative ways of banking and will take steps to proactively contact customers who may have problems accessing alternative banking facilities. In these cases we can offer one-to-one appointments providing advice and practical solutions, including training on telephone and internet banking where appropriate. If any cases of difficulty are raised with you, I would be grateful if you could bring them to my attention so that we can do our utmost to arrange for appropriate assistance.

I hope that this helps to explain this decision and sets out how HSBC will provide assistance to our customers affected by the closure.
