Afternoon Steven,
I have spoken with Lesley at North Riding FA and she recommended I speak with you with regards to some queries about the facilities here at Kirkbytownside.
Attached is a plan of the sportsfield. The football changing facility, toilets and club house is the long rectangular building located half way up the western boundary. Access to the car park and other sports clubs is between this building and the pitch. Can you confirm if there are any regulations in place that would prevent the Junior football teams from using these facilities based on the location for the premises?
The premises are in need of an upgrade and in order to ensure that the works satisfy all FA requirements it would be very useful to arrange a site meeting with yourself in order that you can recommend the extent works needed to ensure compliance.
I look forward to hearing from you and hope that you can help in this regard.
