18.c. To note the ICO's Statement on the General Data Protection Regulations and advice from SLCC confirming that a Data Protection Officer cannot be appointed until the legislation is made to state if the Town Council require one

The Secretary of State for Digital, Culture, Media and Sport, Matt Hancock, has published a proposed amendment to the Data Protection Bill which, if enacted, will exempt all parish councils in England, community councils in Wales and Charter Trustees from the requirement to appoint a Data Processing Officer (DPO). All other requirements of the GDPR will remain in force and councils are urged to ensure they are compliant by the 25th May. The change follows extensive lobbying by the sector, supported by SLCC. https://publications.parliament.uk/pa/bills/cbill/2017-2019/0190/amend/data_rm_rep_0425.pdf

The proposed amendment will be considered as part of the House of Commons Report Stage which colleagues at NALC believe will take place in the next few weeks.

This means it has been published that the government are to consider exempting Councils from the need to have a Data Protection Officer but Councils cannot take this as red that it will go through. Parliament has to debate the bill and approve it so you need to await the legislation on the 25th May 2018. The Information Commissioner has stated the below:

That GDPR is a journey and as long as Councils are working towards embedding the right processes and procedures in GDPR she wants to reassure Councils that they will find a fair and pragmatic regulator.

You cannot appoint a DPO until the legislation is made to state if you do or do not require one.
