a) To consider and agree the need for fencing at the half basketball court

15. To consider and agree to offer support to Michael Hill C.Eng MIET and resistance to those who look to denigrate him again

16. To receive information on progress of the review of NYCC's policy towards Vehicle Activated Speed signs

I am writing to update you on the progress of the review being carried out by the County Council's Transport, Economy and Environment Overview and Scrutiny Committee looking at the council's policy towards Vehicle Activated Speed signs.

We received a good level of response from parishes to the questionnaire sent out in March this year. The consultation deadline closed in May. The results showed that 58% of those responding would consider purchasing and maintaining a Vehicle Activated Sign (42% would not). Vehicle Activated Speed Signs (signs showing the speed limit) were the preferred option over Speed Indicator Devices (signs showing the speed that a vehicle is travelling) (50% would consider purchasing and maintaining a Speed Indicator Device whilst 50% would not.)

The Members on the review group met in June and have agreed to recommend that the County Council changes its policy to allow parishes to purchase and maintain a Vehicle Activated Sign. The task group is in the process of finalising a report to go to the Committee meeting on 12 July 2018. Subject to the deliberations at that meeting the report with recommendations will go to the Executive for approval.
