## The Ryedale Plan - Local Plan Sites Document and Policies Map Notice of Adoption

You, or your organization has previously engaged in the consultation on the preparation of this Development Plan Document. This letter is to notify you that the District Council has formally adopted the Ryedale Plan – Local Plan Sites Document, with the Policies Map, and the formal Adoption Statement is on the other side of this letter.

It should be noted that the Local Planning Authority is required to retain your information during the plan making process. The information you submit relating to the Ryedale Plan can only cease to be made available six weeks from the day after the date of the formal adoption of the Local Plan Sites Document. If we do not hear from you between the date of this letter and the 6-weeks post the Plan's adoption, we will remove your details from the database, and securely dispose of any paper which contains personal data, as soon as possible.

## Planning and Compulsory Purchase Act 2004 Regulations 26 and 35 of the Town and Country Planning(Local Planning) (England) Regulations 2012 Adoption Statement - Ryedale Plan - Local Plan Sites Document

This Statement gives notice that Ryedale District Council adopted the Ryedale Plan - Local Plan Sites Document Development Plan Document and the Policies Map on **27 June 2019**. The Ryedale Plan - Local Plan Sides Document is the final part of the Local Plan for the District. It identifies commitments and allocations for housing, retail and employment land, and provides site specific policies, including policy for new and amended Visually Important Undeveloped Areas. The Plan covers the period 2012- 2027. The Policies Map shows in plan form all the site/area- specific policies or designations.

The adoption of the Ryedale Plan - Local Plan Sites Document and Policies Maps means that all of the 'saved' Ryedale Local Plan Polices, adopted in 2002, have now been replaced, including the Proposals Maps.

The Ryedale Plan - Local Plan Strategy has been subject to an examination by an independent Planning Inspector appointed by the Secretary of State between March 2018 and June 2019. The Inspector's Report was published on the 4 June 2019. The adopted Ryedale Plan - Local Plan Sites Document and the Policies Maps incorporates the Main Modifications recommended by the Inspector and set out in the appendix to the Inspector's report. There are also a number of minor Additional Modifications.

Any person(s) aggrieved by adoption of the Ryedale Plan - Local Plan Strategy may make an application to the High Court under Section 113 of the Planning and Compulsory Act 2004 on the grounds that:

The document is not within the appropriate power of the local authority; or

That a procedural requirement has not been complied with.

Any such application must be made no later than the day (**9 August 2019**) which is six weeks from the day after the date on which the Ryedale Plan – Local Plan Sites Document was adopted.
