- 6. Community Support
- a) To receive an update from a representative of the Community Support Organisation (CSO), pursuant to Minute 20021

The CSO has been put in place as a temporary measure, but we are not expecting to be winding down any time soon. We have worked to recruit and support a number of NYCC Community Volunteers and work alongside/closely with the volunteers within the Ryedale Covid-19 Network. Throughout the last few weeks we have been attending and support the RDC Community Connect meetings and have been part of the team developing and reviewing the SWOT request recently issued. I'll try and give Chris a ring about this today if possible.

With regards to the Community Kitchens, at present they are very much a Ryedale Covid-19 Network development supported by the CSO, RDC and NYCC. The Kitchens originally were established to meet a real need, to support those self-isolating/shielding who could not get out for food and/or were unable to provide for themselves. Whilst this remains a key objective, the user-group has widened and the kitchens are now being accessed by many people who are considered vulnerable, isolated, of lower income, have been impacted financially by covid-19. This week we are commencing a significant programme of reviewing all current users as we do not wish to fall into a situation where the Kitchen has become a 'regular' part of people's lives. Our role as a CSO will be to establish the underlying challenges and identify potential onward referrals/options for current users.

To this end a kitchen in Kirkbymoorside might only be needed if there is a known/identified 'need'. Unless we were identifying significant numbers together, we could potentially look to support any low numbers through the other kitchens. Food is all produced and chilled for delivery so this could be a solution if needed.

The final point you made about the Town Council wishing to support in anyway it can, is really welcome. Even though we are entering week 11, it makes a lot of sense for the town/parish councils, the CSO and the Ryedale C-19 network to work closer together.

- c) To note the response from Ryedale Federation with regards to the arrangements for families eligible for a free school meal, pursuant to Minute 20021
 - The Ryedale Federation has made the following arrangements for all four schools in the federation, for children eligible for a free school meal (excluding universal infant free school meals):
 - Whilst we were waiting for a voucher scheme to be established, we made payments direct into parents bank account to cover the 4 week period 23rd March 17th April, which included the Easter holidays. We gave parents £3 a day for each eligible child.

The national voucher scheme does not include the co-op and for many of our parents the co-op is the only local supermarket available to them. We therefore took the decision to purchase co-op gift cards rather than use the national voucher scheme. These cards are topped up every 1-2 weeks with the equivalent of £3 a day per eligible child.

With effect from week commencing 1st June, meals will be provided for children attending school. For children eligible to free school meals who do not attend school, we will continue to top-up the co-op gift cards

8. Town Council Standing Orders and Charges

c) To consider the period of Exclusive Right of Burial to a period not exceeding 100 years and to review the charges for the Exclusive Right of Burial from 1 April 2020

The Local Authorities' Cemeteries Order 1977:
Grant of burial rights and rights to erect memorials, and agreements for maintenance of graves and memorials
Article 10. (1) A burial authority may grant, on such terms and subject to such conditions as they think proper—

- (a) to any person-
- (i) the exclusive right of burial in any grave space or grave, or the right to construct a walled grave or vault together with the exclusive right of burial therein; or
- (ii) the right to one or more burials in any grave space or grave which is not subject to any exclusive right of burial;
- (b) to the owner of a right described in (a)(i) or (ii) (or to any person who satisfies them that he is a relative of a person buried in the grave or vault, or is acting at the request of such a relative and that it is impractical for him, or such relative, to trace the owner of the right so described), the right to place and maintain, or to put any additional inscription on, a tombstone or other memorial on the grave space, grave or vault in respect of which the right so described subsists;
- (c) to any person, the right to place and maintain a memorial in a cemetery otherwise than on a grave space, grave or vault in respect of which a right described in (a)(i) has been granted, but—
- (i) in the case of a memorial to be placed in a chapel provided as mentioned in article 6(1) (b), only at the request of persons appearing to the burial authority to be representative of the Church of England or other particular denomination or religious body at whose request the chapel was provided; and
- (ii) in the case of any other memorial being an additional inscription on an existing memorial, only with the consent of the owner of the right to place and maintain such existing memorial. Article 10. (4) A burial authority may from time to time extend the period of any grant under paragraph (1) or under paragraph (1) of article 9 of the order of 1974 or any enactment replaced by that provision (subject, if they think fit, to any modification of its terms or conditions) for up to 100 years from the date on which the extension is granted.

Note from YLCA:

In the Associations opinion the council would need to consider the cost implication of amending the term of the Exclusive Right of Burial. If after 30 years the deed holder is asked to purchase a further 30 year Exclusive Right of Burial at £xxx the council would receive income for the additional 30 years. If the council extend the period to e.g. 75 years then the councils income would be less unless the initial purchase cost for the Exclusive Right of Burial, for the 75 years, is increased.



Press Release:

Hidden Disabilities Sunflower Scheme

Not all disabilities are visible or immediately obvious, such as learning difficulties, dementia as well as mobility, visual or hearing impairments. Living with a hidden disability can make daily life more demanding for many people, but it can be difficult for others to recognise, acknowledge or understand the challenges faced.

Wearing the Hidden Disabilities Sunflower discreetly indicates to people around you that you may need additional support, help or just a little more time. The Hidden Disabilities Sunflower has increasingly been adopted by large supermarkets, airports, and other geographical areas and it intends to allow everyone with a Hidden Disability to choose to be subtly visible when they need to be.

The Ryedale Town Councils supported promoting the scheme across the district and they have identified that as well as raising awareness of hidden disabilities in general, the Hidden Disability Sunflower Scheme would also be helpful in the current environment of social distancing, as it can be difficult for those with disabilities to be able to put social distancing into practice and raising awareness of this difficulty through local businesses and the wider public is important in our current climate.

With the support of NYCC Stronger Communities; Helmsley, Kirkbymoorside, Pickering, Malton and Norton Town Councils, Ryedale Special Families, Ryedale Sight Support and Camphill Village Trust have all now registered with the scheme and purchased a supply of materials, which includes the sunflower lanyards and badges. Ryedale District Council are also supporting the scheme.
