10. Town Farm car park

a. To receive information on the installation of Electric Vehicle Charge Points

Installation of 2 x double socket 22kW Electric Vehicle charging points in Town Farm car park.

Further to a successful bid for funding to the Office for Zero Emission Vehicles, RDC will be installing these units at all long stay car parks in the District by 31 March 2021, supplied by Connected Kerb. The units will be aimed at providing local residents without access to off-street charging the ability to charge their vehicles, and help transition more of the residential community to acquire an Electric Vehicle. They will also be available to the wider public and visitors to Kirkbymoorside.

The works at Town Farm car park, Kirkbymoorside are scheduled to take place w/c 22 March including connection works by Northern Powergrid.



The groundworks for the pillar and charging posts have been done, now awaiting Northern Powergrid to do the excavation and connection between 23-25 March. They are writing to residents on Town Farm Close as there will be works on the highway, but not affecting vehicle access in or out. The Comms team will engage with residents without off street parking in the town so they are aware the units are being installed.

11. Devolution

a. To receive the Ministry of Housing, Communities and Local Government consultation proposals for locally led reorganisation of Local Government in North Yorkshire

Ministry of Housing, Communities and Local Government consultation proposals for locally led reorganisation of Local Government in North Yorkshire

The consultation seeks views on the locally led proposals that the Secretary of State has received following his invitation to councils in North Yorkshire to submit proposals for local government reorganisation (note that the consultation also includes the areas of Cumbria and Somerset). The North Yorkshire proposals in this consultation were submitted in a joint bid by Craven District Council, Harrogate Borough Council, Richmondshire District Council, Ryedale District Council, Scarborough Borough Council and Selby District Council and in a separate bid by North Yorkshire County Council. The Paper asks a number of questions about each proposal to help inform the Secretary of State's assessment of the proposals, including (but not limited to):

- Whether each proposal will improve local government
- Whether there is a good deal of local support in the round for the proposal
- Whether the proposed new council areas cover a credible geography.

North Yorkshire • Craven District Council, Harrogate Borough Council, Richmondshire District Council, Ryedale District Council, Scarborough Borough Council and Selby District Council submitted a joint proposal for two unitary councils covering the whole of the area of the administrative county of North Yorkshire and whole of the area of the administrative area of the City of York; one unitary in the east comprising the current districts of Ryedale, Scarborough, Selby and the current unitary of York; and one in the west comprising the current districts of Craven, Hambleton, Harrogate and Richmondshire. • North Yorkshire County Council submitted a proposal for a single unitary council for the whole of the area of the administrative county of North Yorkshire with no changes to the existing City of York unitary. Firstly may I introduce myself. I am Georgina Jackson, I work for North Yorkshire Fire & Rescue Service, and I am the Community Safety Officer for Ryedale District, which includes your parish.

I am contacting you to enquire if we can work together to ensure the people of North Yorkshire and York are safe and feel safe as they go about their business.

The Police, Fire and Crime Commissioner (PFCC) set out her priorities to ensure people are safe, and, I feel as a Parish Council, you are an integral part of delivering this as you know your parishes and where the vulnerable people may be.

The priorities are :-

- Caring about the vulnerable, we can provide a service that will best protect the most vulnerable and make them feel safe.
- Ambitious Collaboration, we can maximise opportunities to work jointly to provide a more effective and sufficient community safety service.
- Realising our Potential, we can create an inclusive work environment and a positive culture.
- Effective Engagement, we can increase trust and public confidence this ensure we provide the best possible service.

Although the PFCC may change, I believe the principles will and should remain the same.

I would be happy to discuss this in more depth, and if that would be possible, I can set out what we could offer to your residents. This would include fire safety advice, road safety initiatives and engaging with local schools/youth groups, however, the list is not exhaustive as I am sure we could work together and be creative how we achieve our aims.
