Last month, the Department for Environment, Food & Rural Affairs and
National Highways launched two consultations on proposals to make it
easier for councils to tackle poor air quality in their areas.
The Consultation on the review of the Local Air Quality Management Policy
Guidance seeks views on increased engagement between councils and the
communities that they serve, and an increased focus on the impact of air
quality on people's health. The consultation will also look at the
stronger requirements introduced in the Environment Act 2021 for other
organisations to collaborate with councils in delivering Air Quality
Action Plans (AQAPs). Meanwhile, the Consultation on Designation of
National Highways as a "Relevant Public Authority" proposes to designate
National Highways in order to ensure more consistent collaboration with
councils to reduce road pollution.

Together, these two measures are designed to significantly contribute to the successful implementation of AQAPs and ensure air quality standards are met in local communities.

Both consultations close on 6 June.

Marine & Coastal Workshop Session $-1.30-3.00\,\mathrm{pm}$ on 1st June From the consultation feedback, there was consensus that the marine and coastal section was relatively under-developed. This session will be focused on addressing this issue - further developing the strategic priorities and expanding the interventions. A full agenda for the session will be circulated early next week.

Net Zero Tourism Workshop Session - 9-10.30am on 7th June

Within the consultation feedback, a number of stakeholders highlighted the missed opportunity to create a sustainable, net zero tourism sector. So this session will be focused on discussing the challenges and opportunities around this, and the required actions to deliver the ambition. A full agenda for the session will be circulated next week.

Community Climate Action Workshop Session - 2.00-3.30pm on 9th June

Within the consultation feedback, a number of stakeholders highlighted the need for the Routemap to empower communities to take climate action and create a two-way dialogue between communities and the regional-level, rather than a top-down approach. So this session will be focused on discussing how we can achieve this through the Routemap, and the required strategic actions and priorities. A full agenda for the session will be circulated next week.

Natural Capital Workshop Session - 11.00-12.30 on 10th June

Within the consultation feedback, there were a number of issues raised around land use, including the need to integrate biodiversity into plans and the omission of reduction in land used for dairy and meat farming. At this session, we will be discussing how to best address the land use related feedback. A full agenda for the session will be circulated next week.

The second round of applications to the Nature for Climate Peatland Grant Scheme (NCPGS) Restoration Grant opened on 6 April 2022. The Nature for Climate Peatland Grant Scheme (NCPGS) provides funding to restore peatlands in the uplands and lowlands of England. It is a competitive grant scheme that will run until 2025. The scheme is open to environmental groups, local authorities, charities, public bodies, individual landowners and organisations.

Ø Two New Grant Programmes to Improve Outcomes for Disabled People

National charity Motability has announced it will provide £50 million to UK charities and organisations in the accessible transport sector from 2022 to 2025, starting with two new funding streams:

- Community Transport Grants
- Wheelchair Sector Grants

There is a focus on medium and large charities and non-profit organisations with well-established ways of working. As such, applicants must have been active for three years, with an annual income of at least £150,000 in that time. Community Transport Grants should be used to cover:

- Staffing and/or volunteer costs to increase supply of Community Transport services.
- Leasing or buying Community Transport vehicles
- Initiatives to influence transport strategy, policy and funding.
- Partnerships/collaborations which drive efficiency at the organisational and systems level.
- Best practice interventions to continue/scale up work.

 \emptyset Funding to Support Energy Consumers in Vulnerable Situations in Great Britain

The Energy Redress Fund has reopened for 2022. There is a total of £23 million to fund new projects, with grants ranging from £20,000 to £2 million.

Registered charities in England, Scotland and Wales that are registered with the Energy Redress Scheme and have passed the due diligence process may apply for the Small Projects Fund, Main Projects Fund or Innovation Fund.

Examples of the kind of activities that can be funded through the Energy Redress Scheme include:

- Engaging vulnerable customers with energy issues and referring them for support.
- Delivering energy advice that does not duplicate existing advice services.
- Installation of energy saving or renewable energy measures that cannot be funded elsewhere and/or are innovative or are being used in innovative ways.
- In-home safety advice and measures related to energy systems.
- Training and education on energy that is targeted at supporting vulnerable customers.

Grants can cover capital or revenue funding for projects lasting up to two years.

The Carbon Emissions Reduction Fund supports initiatives principally aimed at reducing the climate change impact associated with energy use, which relate to OfGem's regulated areas of energy generation, distribution, supply and use.

There is a total funding pot of £4 million, with grants of £50,000 to £1 million on offer. Previously only open to registered charities, this fund

will now also accept applications from Community Interest Companies, Community Benefit Societies and Cooperative Societies in Great Britain, provided they are registered with the Energy Redress Scheme and have passed the due diligence process.

The funding is for projects that meet the following criteria:

- Can demonstrate measurable and lasting reductions in the carbon intensity of energy end use and accelerate the transition to net zero carbon dioxide emissions.
- Have a realistic prospect of delivering broadly replicable benefits to existing and/or future energy consumers.

Grants can support both capital and revenue costs for projects lasting up to two years.

The deadline to apply is 5pm on 6 June 2022.

 \emptyset Launch of £1m Fund to Boost Reusable Packaging (more about packaging below)

Created by Hubbub, in partnership with Starbucks, the Bring It Back Fund aims to support innovative projects to increase the adoption, and remove barriers for, reusable packaging in the food and drink sector.

Grants of between £150,000 and £300,000 are available. Successful applicants could promote behaviour change, undertake new research, expand an existing approach or attempt something completely new, including technical fixes.

UK registered organisations from any sector may apply. Applications must be submitted online by the deadline of 24 June 2022.

Ø Funding to increase domestic tree production opens: The Forestry Commission, in partnership with the Department for Environment, Food and Rural Affairs, announced a new fund providing up to £8.8 million to support domestic tree production in England. The funding, open to councils, will help tree nurseries and suppliers invest in projects which improve, expand, automate or mechanise their operations. This will support efforts to build nursery capacity and grow long-term tree seed and sapling supply. Successful projects will be awarded up to £175,000 in grant funding to cover up to 50% of costs, with money coming from the Tree Production Capital Grant as part of the government's £750 million Nature for Climate Fund https://www.gov.uk/guidance/tree-production-capital-grant

Ø NY Liftshare - please encourage your contacts to promote NY Liftshare to share lifts for their daily commute, or any other journey.

"As people start to return to the office, councils across North Yorkshire are encouraging residents to share their work commutes - and save money.

They say that lift sharing can also help to reduce harmful greenhouse gas emissions - and a new website can make it easy to access.

Nationally just under 70% of workers drive to work - with the average return commute is just under an hour. And in North Yorkshire this could be even higher with people living in rural communities having longer journeys.

On average, a petrol car emits over 111g of CO2 every mile travelled, which means a 20 mile trip will see 2,237g of CO2 emitted. An average commute can cost £10, so sharing the journey with one or two people will cut a five-day expense of around £50 to £25 or even £16 per person. Over an average four-week month, this is a saving of £100 if you car share with one person, or £133 if you share with two people.

Through the Liftshare website - Liftshare.com/uk<https://liftshare.com/uk> - you can input a journey start (your home postcode) and the destination postcode (work address), select whether or not it is a return journey, whether it would be regular or a one-off, and what days you would be wanting to travel. Following this you put in your leaving and return times (if it is a round trip), and find your matches by choosing between being the driver or passenger, then Liftshare does the rest! "
