#### 14. To receive an update on Q2 progress for the Flood Risk Management project

Over the summer the project has secured an additional 10k from the North York Moors National Park's Farming in Protected Landscapes Scheme, and has engaged with the River Restoration Centre, to support the feasibility and detailed design work to investigate floodplain reconnection opportunities at two sites along the River Dove.

Floodplain re-connection will restore natural processes to targeted parts of the river where currently the floodplain is not being activated regularly during high rainfall events. By activating the floodplain more regularly there is opportunity to slow the flow of floodwaters, reducing the volume within the river channel, providing a flood risk benefit downstream.

Additional biodiversity benefits will also be developed alongside the plans, including floodplain meadow and wetland restoration work, to ensure the sites are delivering a multi-benefit approach. Landowner engagement in the upper catchment is underway, with three farms visited so far and several more planned over the autumn and winter.

A number of Natural Flood Mitigation (NFM) measures are being discussed with landowners including creating temporary flood storage areas, leaky dams, tree planting and soil aeration. It is anticipated some 'quick win' measures will be delivered over the coming winter as agreements with landowners are progressed.

A pipeline of NFM measures is being collated, which will support the submission of the full business case over the winter. Approval of the full business case will unlock the budget necessary to deliver these measures in 2024/2025.

#### 15. To receive information from North Yorkshire Council regarding management of Town Farm car park

As you will be aware the eight councils in North Yorkshire merged on 1 April to become a single unitary authority – North Yorkshire Council (NYC). As part of this process all assets and facilities including car parks transferred into the new authority. Over the last 6 months the complicated process of merging all sites and staff into a single team has been started with a full service restructure to follow in the second half of the year. As a result of the merger, NYC now has in the region of 130 car parks, in addition to onstreet parking provision and the less formal areas where parking can / does occur.

Whilst there are no firm details to share at this time, it is highly likely that in order to manage and operate such a large number of car parks, work will need to take place on the parking strategy and policy for the new council. Timeframes are not currently available for this but it is expected this will include a range of elements such as enforcement and tariff structures, as well as signage and the types of spaces / parking provision. Clearly this will be a huge task given the number of locations and the 8 different methods of delivering and managing this provision that currently exists, so it may take some time and / or happen incrementally. Until this work has taken place all car parks are continuing to operate as they do currently, but we continue to be happy to consider any request for support for events such as the forthcoming Christmas Market.

Sorry we are unable to provide more clarity at this time but please bear with us, and as soon as there is more detail there will be opportunity for communication and consultation with local stakeholders.

Subject: Kirkbymoorside Town Council support for Climate and Ecology Bill

I'm writing on behalf of Zero Hour and seeking Kirkbymoorside Town Council support for the <u>Climate</u> and <u>Ecology Bill</u>, which is due for its second reading on <u>24 November</u>.

We recognise that parish and town councils are influential organisations, with links to the local community, regional charities and civic bodies. Kirkbymoorside Town Council is on the front line when it comes to protecting the places and communities we love and cherish.

We are writing to ask your council to join the <u>168 parish & town councils</u> across the UK to support the <u>Climate and Ecology Bill</u> and add your voice to those organisations calling for joined-up action that provides an adequate, commensurate response to the emergency of our natural world, our parks, villages and towns, our landscapes and wildlife.

We have a <u>draft motion</u>, which you may find useful. If Kirkbymoorside Town Council is supportive, we are asking that after the motion is passed, Kirkbymoorside Town Council issues a press release that it has done so and writes and requests your MP(s) to also publicly support the CE Bill *(if they are one of the <u>130 that have already done so</u>, please write and thank them for being supporters).* 

The <u>Climate and Ecology Bill</u>, if made law, would ensure that:

- The threat facing nature is tackled shoulder to shoulder with the climate crisis in a joined-up approach.

- The Paris Agreement is enshrined into law to ensure that the UK does its real fair share to limit global temperature rise to the most stringent end of the Paris agreement - 1.5°C.

- The UK takes full responsibility for our entire greenhouse gas footprint by accounting for all of the emissions that take place overseas to manufacture, transport and dispose of the goods and services we import and consume)-

- The government deliver a climate and nature assembly that is representative of the UK population, working directly with the Government and Parliament to ensure that all voices are heard and that no one is left behind.
