

Kirkbymoorside Town Council Town Celebration and Community Awards Policy

Introduction & Background

It has been the practice of Kirkbymoorside Town Council to make one or more awards annually to individuals in the community who have made a positive contribution to the town and the people who live in it.

At the Town Council meeting in July 2023, a discussion took place in relation to developing this into a wider 'Town Celebration and Community Awards' event. It was recorded as in agenda item 10:

To consider an event for presentation of the 'Community Awards' and an opportunity to acknowledge the community's achievements over the previous 12 months, including receipt of reports from local group and charities.

Subsequently a draft proposal was prepared and presented by Town Councillors.

The following is now the Town Celebration and Community Awards Policy, setting out the Purpose & Policy Statement, Definitions, the Procedures, and Additional Supporting Information.

Purpose & Policy Statement

The purpose of the Town Celebration and Community Awards is to provide the platform from which the Kirkbymoorside Town Council can annually acknowledge and celebrate the town and the community's achievements at a special event. It shall demonstrate that Kirkbymoorside is 'A Great Place to Live and Work' and we are proud of and to come from Kirkbymoorside.

Sponsors	a person or organisation that pays for or contributes to the cost involved in staging a public event so that it does not fall on the public purse				
Operating costs	the ongoing expenses incurred from the normal day-to-day / annual running of the Town Celebration and Community Awards				
Communications	the means of sending and receiving information about the Town Celebration and Community Awards				
Promotion	the publicising of the Town Celebration and Community Awards so as to increase public awareness

Procedures

The Community Awards shall consist of four **categories** for public nomination, plus an overall Kirkbymoorside Community Achievement Award to be determined by the Town Council.

The award categories shall be: The voluntary organisation / charity of the year

The membership group of the year

The 'quiet contributor' of the year

The young person of the year.

The **criteria** for each of the awards are detailed in the Additional Supporting Information section.

The Awards will consist of recipients having their names enrolled on an **Honours Board** (the property of Kirkbymoorside Town Council but hung by kind permission of the Kirkbymoorside Memorial Hall Management Committee in the Memorial Hall and on permanent display). The Town Council shall also consider other personal mementos such as but not restricted to a framed certificate.

The Community Awards public **nomination process** shall be launched annually six (6) months before the date of the Town Celebration and Community Awards presentation events (usually but not restricted to October). The closing date shall be one month before the events. There shall be no charge to submit nominations. Illustrative nominations forms are provided in the Additional Supporting Information section.

Judging shall take place during the month following the closing of the nominations process, and prior to the Town Celebration and Community Awards presentation events. The judging panel shall be made up of the Mayor and Councillors representative of the Town Council (all of whom shall be required to declare any interest in any of the category nominees and withdraw from the judging process). The decisions of the Town Council in the judging process shall be final and no correspondence shall be entered into.

The **Town Celebration and Community Awards presentation events** shall be comprised of:

- A daytime event open to the public where voluntary organisations, charities and community organisations based in or around Kirkbymoorside can showcase and celebrate their organisations and their contributions to the Town.
 - a) They shall be permitted to promote their work, engage with members of the public attending the event, fundraise by selling relevant items, attract new members and volunteers, or provide information.
 - b) Organisations will be invited to request a space at the event; it shall be the decision of the Town Council as to which are allocated a space in order to ensure a fair and representative mix of the local organisations. There will be no charge to the organisations represented.
- 2. An evening event on the same day for the Community Award short-list and winners, their nominators, representatives from the organisations taking part in the daytime event, Kirkbymoorside Town Mayor and Councillors, event compère, event sponsors, a photographer, and those providing any refreshments and entertainment.
 - a) The maximum numbers and mix of invitees shall be limited to the capacity of the event venue(s).

b) The associated decisions of the Town Council in managing this shall be final and no correspondence shall be entered into.

These events shall be dependent on the successful securing of one or more **sponsors** annually to meet the **operating costs**.

Kirkbymoorside Town Council shall launch the opening of the Awards process through a range of appropriate **communications**, and shall undertake **promotion** of the events and award winners to the press and media to demonstrate its pride in Kirkbymoorside and its people.
