Lighting:

Where cameras have been quoted for, unless otherwise stated, these will be colour/mono with built in Infra-Red or additional white lighting and auto sensing depending on lighting conditions.

Modern IP CCTV cameras will work in very low lighting levels typically 0.002/0.0002 Lux* colour/mono @ F1.4; Although for good quality video we recommend at least 3.0 lux, preferably white light. * Lux measured at the camera.

We recommend after installation that customers evaluate that their CCTV night-time performance is adequate taking into account any site lighting and operational requirements and if necessary review additional ambient site lighting or request an engineer to assess the camera performance and make further recommendations.
