- c. **To note the new Section 137 expenditure limit for 2026/2027 financial year of £11.60 per elector, up from £11.10 in 2025/26**

New Section 137 expenditure limit for 2026/2027 financial year

The Ministry of Housing, Communities and Local Government (MHCLG) has increased the Section 137 expenditure limit for parish and town councils in England for the 2026/27 financial year. The new limit is £11.60 per elector, up from £11.10 in 2025/26.

The increase reflects the percentage rise in the retail price index between September 2024 and September 2025, in accordance with Schedule 12B of the Local Government Act 1972. Section 137 of the Act allows parish and town councils to incur expenditure for purposes that benefit their communities when no specific statutory power is available.

All YLCA member councils are asked to note the new s137 expenditure limit and calculate the total expenditure for the 2026/2027 financial year by calculating £11.60 x total number of electors on 1 April 2026 to give the maximum amount the council can spend using this power of last resort in the 2026/2027 financial year.
