Our base is in Norton, Malton and in order to provide support across Ryedale, for those who cannot travel to Norton, we run outreach groups. One of those outreach groups takes place in Kirkbymoorside. Last year Kirkbymoorside Town Council generously gave Next Steps a grant for the costs of the facilitator. The group meets every Saturday morning. Plans are underway to move from the present location to Church House, which will offer a more central location to the group. The group meets to support each other and find times to discuss their issues. This is a long running service for the people of Kirkbymoorside. The group is fairly small, with a regular membership of 4 or 5 but provides an invaluable service to those who attend. We are requesting support from the Town Council in order to maintain this service for the people of Kirkbymoorside. Incidences of mental health problems are extremely prevalent at the current time. People are experiencing higher levels of anxiety and depression and are looking for additional support. It is of great benefit that we can offer this weekly support to people without having to travel outside of the local community, incurring expensive travel costs. The group is facilitated by a member, with support from the Service Manager. The facilitator is paid on the permitted work scheme and receives a modest wage.
