F17037 Minutes and Matters Arising

The minutes of the Finance Committee meeting held on 5th October 2017 were **received** and **signed**.

There were no matters arising.

F17038 Public Session

There were no members of the public present.

F17039 Councillors' Audit

It was **noted** that a review of the monthly financial reports, business continuity and the risk assessments have been carried out for quarter 3 by Councillors Coughlan and Dowie. Q3 auditors recommended the internal audit checklist be amended to distinguish Precept from the Reconciliation checks so the format order appears as 6. Reconciliation, 7. Precept, 8. Petty Cash. Agreed.

F17040 The Internal Audit arrangements and timescales were **reviewed**.

F17041 The Internal Audit Terms of Reference were **reviewed**.

F17042 The financial and other risks facing the council, and internal and external controls in place for management thereof, were **reviewed**.

F17042 The Risk Assessment Strategy was **reviewed**. It was proposed by Cllr Coughlan and agreed to include details of the adoption by the Town Council of a Community

Resilience and Emergency Plan which demonstrates the Town Council's awareness of risk.

The value of items on the Council's Asset Register were **reviewed** and include the increased value of street lighting columns subsequent to completion of Phase 1 upgrades to LED and the addition of the basketball court at Old Road play area. It was agreed to liaise with Moore Stephens to determine whether auditors requirements will be to include or not include the cost of installation to the value of the street lights, and check with NYCC with regards to specific material costs associated with Phase 1, as necessary.
