Minutes of a meeting of the Kirkbymoorside Town Council held at Church House, Kirkbymoorside, on Monday 20th May 2019 at 7.30 pm

Present: Councillor A Ashworth (Chair), S Brown, J Coughlan, J Cossins, C Dowie and N Holroyd.

Also present: District Councillors David Cousins and Toni Riby, the Town Clerk L Bolland, invited guest speakers Stewart Rogerson -Co-op representative, Barnaby Fryer - Co-op Sustainability Manager, Nigel Brass - Store Manager, and 5 members of the public.

Councillor Ashworth welcomed all present

- **19001** The Town Council **resolved** to elect Councillor N Holroyd Chairman and Town Mayor for the year 2019/20.
- **19002** Cllr Holroyd signed the Declaration of Office of the Town Mayor after conclusion of business of the meeting.
- 19003 Councillor Ashworths report of the year 2018/19 was received. Appendix A
- **19004** On behalf of all members of the Council Cllr Holroyd offered a vote of thanks to Councillor Ashworth for his work during the year 2018/19 and the preceding years.
- **19005** the Town Council **resolved** to elect Councillor J Coughlan Deputy Town Mayor for the year 2019/20.
- 19006 The Declaration of Acceptance of Office of Councillors was recorded.
- **19007** The completion of Mandate for Local Authority in accordance with Financial Standing Orders was **recorded.**
- **19008** Apologies for absence were received from County Councillor Val Arnold.
- 19009 There were no Declarations of Interest in items on the agenda made at this time.

(Cllr Coughlan declared an interest in items 22.a. I & II at the time of consideration of the same, later in the meeting).

Cllr Holroyd proposed that the order of the agenda be revised to receive agenda item 21 to allow the invited guest speakers and representatives the opportunity to present earlier in the meeting. **Agreed.**

19010 Co-op Store

- a) Correspondence was **received** from Kirkbymoorside Environment Group in respect of their communications with the Co-op outlining their wishes for the new store in the town.
- b) Information was **received** from the Applicant and Agent of the proposed new Co-op store. Appendix B & C.

Cllr Dowie proposed that the Town Council support the initiatives of the Kirkbymoorside Environment Group by facilitating discussion with Ryedale Garages (Ltd) (the Applicant) and the Coop (the Agent), and local groups, businesses and residents. Agreed. Residents and local groups were encouraged by the Applicant to contact the Planning Authority (Ryedale District Council) directly with any comments about the planning application or considerations that should be factored to ensure a more representative consultation.

Cllr Brown suggested that the information that had been displayed in the Co-op store detailing the intention to expand the store should be made available to display in the town centre to ensure that more people are informed.

The Town Council **resolved** to establish a dialogue with the associated parties to achieve a highly successful development for all.

Cllr Holroyd thanked the representatives for taking the time to present to the Town Council and their attendance at the meeting.

- 19011 It was agreed to maintain the annual allowance for the Mayor at £500 to be claimed as and when expenditure was incurred. The public wi-fi data allowance has been doubled to 1GB at with no additional cost implications too the Town Council.

All residents who participated in the consultation regarding the proposal to install lighting at Old Road play area have been notified of the outcome being that the matter will not be pursued.

Correspondence regarding the proposed 'Stub it, Bin it' campaign has been issued to all eateries in the town centre with a deadline for responses of 31st May. Display of appropriate notices will be determined by the responses of the local businesses and their willing to participate in the campaign.

The new 'Welcome to Kirkbymoorside' panel is now ready to be installed on the approach from Helmsley. This will ensure consistent design and content as the sign on approach from Pickering.

- **19023** Correspondence was **received** from a member of the Northern Ryedale Transport Group. It was agreed to display information relating to local transport services in the Town Council noticeboard provided that there was sufficient space to display Town Council Notices. The Council asked the Town Clerk to explore the options available for better signage at the bus stops and the feasibility of relocating the Town Council noticeboard currently located on the exterior wall of Age Concern to another location in the town centre.
- **19024** There were no reports from Members representing the Town Council at meetings of outside bodies and delegated matters.
- **19025** The Town Clerk's report was received and the following information noted:

The S106 grant application for additional features for the half basketball court at Old Road play area was submitted to RDC in time for the 10th May deadline.

A letter of thanks has been received from Kirkbymoorside Primary School for the support of the Town Council of the 10k event.

There is a possibility of a trial pilot for a shared dog warden in Ryedale. More information will be presented to the Town Council when it becomes available.

NYCC Highways Authority are making preparation for the consultation in respect of the proposed 20mph speed limit which will extend the full length of Tinley Garth, West End and Westfields to the A170 junction. The Town Council will be included in the primary consultation.

The 2018/19 Street lighting energy cost show a reduction of 45% from 2017/18 costs due to the upgrade to LED.

The 2018/19 VAT return in the amount of £11,439.37 will be submitted to HMRC on 22nd May.
