7. To receive information about the Community Mapping Project set up jointly between the OPCC and North Yorkshire Police and agree participation in the project

The Office of the Police and Crime Commissioner (OPCC) for North Yorkshire, are working on a community mapping project set up jointly between the OPCC and North Yorkshire Police (NYP). The aim of this project is to map local communities and organisations, the policing and crime concerns of these communities, and the best way to engage with them.

I'm trying to visit as many towns, villages, parishes etc. as possible. I've already undertaken fieldwork for this project in the Craven and Richmondshire districts. I am aiming to be working in the Ryedale district from March onwards, and I would like to find out more about Kirkbymoorside. In previous visits I have used parish and town councils as a starting point for finding out more about the local area. I would really like to meet with you, or the full council for Kirkbymoorside, where I aim to:

- Find out more about local groups and organisations
- Understand local policing and crime issues
- Investigate how the OPCC and North Yorkshire Police can best contact the local community

It would be great if we could arrange a meeting involving representatives from the Council and from local organisations, or if I could attend an upcoming Council meeting and talk to the councillors about this project. Otherwise, I am happy to speak to yourself or another representative of the parish, or meet with the councillors at an alternative arrangement. Finally, whilst I represent the PCC and North Yorkshire Police, I am unable to formally pass on any concerns or complaints. I can provide you with contact details and information about policing in North Yorkshire, but unfortunately it does not fall in the remit of my project to open cases of enquiry.

8. To consider and agree to support Kirkbymoorside Environment Groups' Plastic Free initiative

The Kirkbymoorside Environment Group would ask Kirkbymoorside Town Council to support the initiative to make Kirkbymoorside plastic free.

The initiative can be supported by the following means:

- a) Litter picking in and around the town. The amount of plastic waste on the A170 verges is considerable.
- b) Assisting with the cost of printing and distribution of a questionnaire to all town businesses, asking them how they can reduce plastic use. Each business has its own 'easy hits', and more difficult areas to deal with. We need to know from them what their difficulties are and how their customers, the Town Council, District Council, County Council and or government could help. Plastic waste is a multi-layered problem, with multi layered areas of responsibility.
- c) Assisting with the cost 'we use less plastic' stickers to be offered to local businesses, and promotional publicity for such a scheme, in conjunction with the other four towns in the district, to send out a unified message. Actions for businesses to consider would include: not offering single use plastic bags/ cups/ straws/ fast food boxes. Making non-plastic alternatives available such as refillable containers, non-plastic plant pots/ household goods.
- d) Putting pressure on the District Council to make recycling available for commercial waste customers, at no extra cost;
- e) Putting pressure on the District Council to make it much clearer for everyone what plastics can and cannot be put in the recycling and initiating recycling for all plastics;
- f) Asking for a bottle bank deposit return machine for the town.
