Provide a <ul style="list-style-type: none"> • detailed description of the project • evidence of the need for your project, • and show who will benefit from it 	<p>Ryedale Community transport generally operates with over 70 volunteers on our Ryedale Car scheme and 8 volunteers on the minibus fleet. Due to Covid-19 many of our volunteers are either over 70 or have other medical issues and are in self isolation. The impact has been significant, and we are currently operating with just volunteers. To address this, we are using far more paid drivers than we would normally do and although the demand for our services has reduced significantly we are still providing hospital and medical journeys and essential travel for people with specific needs.</p> <p>As the Hospitals at York and Scarborough are gradually opening more clinics and releasing wards from Covid lock down we are seeing a steady rise in demand for hospital transport. To provide a safer environment we have put shields between the driver and passenger compartments in our fleet vehicles which allows greater protection and isolation for all concerned. We have also been required to develop a programme of deep cleaning all vehicles at the end of the day using a chemical cleaning system. The cost of this has been covered by another grant from the Two Ridings foundation and support funding for the deep cleaning is being provided by a grant by Ryedale District Council.</p> <p>We are of course seeing a rise in drivers' costs as the greater burden of these journeys is being undertaken by our own fleet by paid staff. Whilst we are going ahead with these journeys it is against the backdrop of an expected loss of generated revenue for the charity in the 6 months in excess of £30,000.</p>
