detailed description of the project evidence of the need for your project, and show who will benefit from it	This grant application is to enable the group to further the floral enhancement of the town by filling and erecting the existing hanging baskets that we have in stock. This element of our overall strategy is financially weighted as, due to H&S issues we are not permitted as volunteers to water or erect the baskets and must employ someone to do that on our behalf. The baskets are placed in the main thoroughfare and at points along the A170. The grant will cover the planting up, growing on, watering, removing, clearing and storage of baskets. This is done by a local, highly regarded nursery at a very competitive price. The watering and additional feed is provided by a local window cleaner, who possesses the necessary equipment for the task. The project provides benefit not only to residents but visitors, businesses, and travellers along the A170.

CONSTITUTION FOR

THE KIRKBYMOORSIDE IN BLOOM GROUP

NAME

The name of the group shall be The Kirkbymoorside in Bloom Group

AREA

The area of benefit shall be Kirkbymoorside Town

AIMS AND OBJECTIVES

- 1 To protect and enhance the towns natural beauty, wildlife, flora and greenspace heritage.
- 2 To promote Kirkbymoorside's entry into the regional and national In Bloom competitions raising civic pride in the town.
- 3 To organise events and activities in the town to support the aims of the group.
- 4 To act as an advisory body for the community building partnerships between the community, educational establishments and businesses.
- 5 To encourage participation in the local Kirkbymoorside Best Kept Gardens competition.
- 6. To raise funds to support the above activities.

MEMBERSHIP

Membership shall be open to all people or organisations who wish to support the aims of The Kirkbymoorside in Bloom Group.

SUBSCRIPTIONS

There will be no membership fee levied.

GENERAL MEETINGS The Executive Committee shall call at least two general meetings a year of which one must be the Annual General Meeting.

At least two weeks notice shall be given, this shall be done by posting notices in the area.

The quorum shall be five members or one third of the full membership.

MANAGEMENT

a) The group shall be managed by an Executive Committee which will be elected at the Annual General Meeting.

- b) The Executive Committee shall consist of a Chair Person, Vice Chair, Secretary, Treasurer and upto ten other members. The Executive Committee membership shall be from within the Kirkbymoorside in Bloom Group, they shall be free from any pecuniary interest.
- c) The Executive Committee shall have the power to co-opt local voluntary/community groups whose aims are for the benefit of the In Bloom effort. No more than one member can be co-opted from each group.
- d) The Executive Committee will deem a fellow committee member to have resigned if they fail to attend three consecutive committee meetings without good reason.
- e) The Executive Committee shall meet no less than four times a year.
- f) The Chair Person of the meetings will have the right to a casting vote.

FINANCE

- a) The Kirkbymoorside in Bloom Groups financial year shall commence 1 January and run to 31 December.
- b) The Executive Committee shall maintain a bank account(s) in the said name into which all moneys received must be paid. Cheques are to be signed by any two of the following: Chair Person, Treasurer or two other committee members as agreed by the committee.
- c) Accounts will be subject to independent financial review at the end of the financial year.

DISSOLUTION OF THE GROUP

If the Executive Committee decides to dissolve the group then it shall call a Special General Meeting which can dissolve the group by a two-thirds majority.

Any assets, and any money left over after meeting all obligations, shall be applied to purposes in keeping with the aims of the group.

If the Executive Committee no longer exists, any four members may call a Special General Meeting.

There must be two weeks notice for a dissolution meeting.

All books and documents of the group shall be placed with such a person or organisation for safe keeping as the meeting shall decide.
